

Crow Wing County Online Permitting Guide

1. Go to: www.crowwing.us. Then hover over “Online Services”, then click “Land Related Permits.”



2. Follow the menu selection guide on the next webpage to select the right permit type you are applying for.
3. Once in the “online permit portal” page, sign in or Register for a New Account. Account registration will populate a new page:

4. Once you have set up an Account, select your application type from the Home page:

5. For a New Application, begin by locating the parcel using the interactive map, or entering in the data you may already know in the search box (Property ID, Address) or simply scroll on the map to find the location of the property visually. Follow the guides on the property location page for assistance.



6. Make your permit type selection(s) & follow the prompts on the following pages. You may apply for more than one permit type at the same time.
7. In “Project Selections” follow the prompts to add projects to your permit application. Note: Septic Permit applications will automatically generate into the project field.

8. Impervious surfaces – notice the list that generates will include the project proposal. You may also add existing impervious to the project. Note that ALL impervious surfaces known in the software will be listed, so if anything is missing (driveways, patios) you may add it here:

9. Site Plan – You can upload your own site plan here, or utilize the GIS map to print or download an aerial view of the parcel you can sketch on to provide in the application. Complete site plans are required for applications.

10. Payment – note the invoice generated & your options to select your payment preference. Online payments will direct you to a new site where you will have to option to pay with your preferred method. Mail in/Drop off payment details are provided. Please note applications are considered incomplete without payment of fees.


