- Commissioner Diane Jacob called the meeting to order at 3:10 PM.
- Introductions

- ⊕ Meeting minutes and agenda were approved. 1st: Wayne Anderson 2nd: Barb Becker- Motion carried.
- Implementation Structure:
 - Melissa briefly described two types of governance for 1W1P Implementation.
 - Darren suggested he bring a hand-out with more governance detail to the next policy meeting. He let the Committee know they have plenty of time to discuss and decide as it simply needs to be decided by the time the plan goes to BWSR for approval.
- Draft Goals:
